
OFFICIAL GROUNDBREAKING FOR NOEL B. CUMMINGS ADMINISTRATION CENTER

As most of you are aware, the Hodgkins Village Hall is temporarily located on 67th street in the old Carlson Plywood building. The new Administration building is scheduled to completed be in November 2009.

The Village Board has been working on this new project for over two years. The design and selection of the combination of Architects and builders

is a very complex undertaking.

At the 2008 Annual Village Picnic this past September, our Village Officials held a ceremonial groundbreaking (photo). Village President Noel B. Cummings was informed by the Village Board of Trustees that the new building would be named in

building will include a stat-of-the-art meeting room, complete basement facilities, and offices for the entire administration staff. The former building was vacated and demolished due to the inability to efficiently renovate that structure. The new building will be able to support the needs of the Village for many years to come.

As a Cook County States Attorney, Pat handled all kinds of cases, from petty offenses to murder trials. After 6 years of working as a Cook County States Attorney, Pat decided to get into

private practice, and never slowed down.

In 1989, Pat started in private practice as an Associate with John T. O'Connell. He would learn municipal law and became our Village Prosecutor. He worked non stop in this new venture, which lead to a political career in addition to the legal practice.

In 1993, Pat Rogers was elected as the Supervisor of

the Township of Lyons. He has been re-elected three times since. His work ethic was demonstrated in his intensity a n d dedication to the people of Lyons Township. Pat took on many hats and became involved in everything from the local little league to the West Central Municipal

Our Public Works Department is committed to doing its best to keep our village sidewalks, parking lots, and streets as safe as possible. In order to accomplish

this goal, we ask that residents keep a watchful eye for our equipment as we are out and about throughout the village. If you see one of our trucks plowing snow or salting the streets, please give us

plenty of room to do our job. If you are able to park your vehicle in your driveway and off of the street, please do so. This makes our job much easier. When you are shoveling, blowing, or plowing the snow

from your walks and driveways please do so in a manner that is both responsible and respectful to your neighbors around you. AVOID depositing snow from your driveway into the village streets. This creates a slippery hazard, especially if it occurs after we have already plowed and salted. Also, avoid blocking the village sidewalks with snow or parked vehicles.

Following a snowfall, please remove any vehicles from the street so our plows can clean up where any parked vehicles were. This will help in keeping as much snow and ice off of our streets as possible.

NEW SUPER WALMART

Look for great changes in the Quarry Shopping Center with the start of construction for the new Super Walmart. The 80,000 square foot expansion of the existing Walmart should begin as soon as bids are approved by the Bentonville, Arkansas company.

The Village has had a great working relationship with the Walmart Company which also includes Sam's Club. It was back in 1990 when Mayor Cummings first reached out to Sam's Club in order to get them to locate here. He had read in a local newspaper that Indian Head Park turned down the location of Sam's Club in what is now the Flagg Creek Golf Course. The Mayor picked up the phone and invited them out to look at our site.

Of course, at that time the Village had been in law suits with the owners of the truck terminals to condemn their abandoned terminals. The representative for Sam's saw the terminals and turned us down. Subsequently, we were successful in acquiring the property and tore down all the truck terminals. The representative of Sam's happened to return to the site and called the Village. He said they would locate the Sam's Club there if we were willing to develop a full service shopping center there including a Walmart. We said, "you've got a deal". At the time in 1990, retail sales generated was about \$300,000. The assessed property value was \$11,000,000.

Fast forward almost 20 years to 2009. Now, the retail sales generated is \$700 million and the property assessed valuation is \$77 million. That's what you call a "good deal"!

West Suburban Chamber of Commerce Recognizes Hodgkins Couple

Ernest Millsap is a life-long resident of Hodgkins and has been a police officer for 24 years. He married Joan in 1987 and they are busy raising 4 children. Joan was a stay at home mom for a couple of years before going to work for the Hodgkins Elementary School.

Even with their busy family and professional lives, Ernest and Joan have found time to volunteer in their community. Ernest has been a baseball coach for Lyons Township Little League and a softball coach for Countryside Recreation. He is currently in his 4th term as a Village of Hodgkins Trustee.

During the past 11 years, Ernest and Joan have raised over \$100,000

with their DARE "COPS vs. KIDS" basketball game fundraisers held at Gurrie Middle School. According to Pat Rogers, Lyons Township Supervisor, Ernest and Joan schedule the date of the game, send out letters to the communities and staff of school district 105 requesting donations to raffle off. They collect all the prizes, set up a silent auction and coordinate the volunteers. They arrange for volunteers from 3 Police Departments to play in a basketball game against the 8th Grade Gurrie team. They set up everything the day of the event while Joan coordinates the volunteers and raffle, Ernest joins his fellow police officers in the game. As soon as the game is over and the clean-up is done, they begin planning next year's event.

Over the years, the money raised has been donated to families of police officers who were killed

in the line of duty, police officers who have been injured, the American Cancer Society, the 9-1-1 Relief Fund, injured and physically handicapped children, a school reading program, soldiers serving in Iraq, and the list goes on.

Ernest and Joan say, "Helping someone else, no matter what you give, whether it be time or money, is truly a great feeling. The feeling you get from helping someone or helping get a program started is one of the greatest feelings in the world." They believe you should treat others the way you want to be treated and you should always be

a positive role model for your children.

They see nothing but great things for the future of the West Suburban Area and are excited to know they will be a part of the future.

t the October 2008 Village Board meeting, we announced the new severe weather siren was in place and in working order. The new siren replaced the existing one that was mounted on top of the old Pleasantview Fire Protection District Station #3 firehouse located at 6800 Santa Fe Drive.

The original siren was mounted on top of the old firehouse around 1980 and was in need of serious repair. Due to its age and the placement, we recommended the purchase of a new siren and to have it placed on a pole at fifty-five feet high. As an added safety measure, the unit

is also equipped with a battery back up, and can still be activated in the event of a power failure.

The height of this new siren will provide a wider area of coverage. The new siren is the loudest and most commonly installed siren offered by Federal Signal with an output of 130 dB. (decibels). This siren, under the right conditions can produce 70 dB approximately 6400 feet (1.2 miles) from the unit which should provide adequate warning if you are outside your home.

The Village of Hodgkins weather warning sirens are an outdoor warning system



intended to alert people "<u>outdoors</u>" to severe w e a t h e r conditions. The sirens are

> not intended to awaken people from their sleep. The Village of Hodgkins Emergency Services highly recommends that residents purchase a weather alert radio. These radios are tuned to the national Weather Service frequency and will alert you of approaching storm systems. You can find these at most retail stores.

> The sounding of outdoor sirens is your cue to listen to your local radio and/or television for information concerning severe weather in the area. You must make an informed decision on your safety

and the safety of your family and take immediate action. Please, DO NOT CALL 911 to ask for weather information.

The outdoor warning sirens in our area are tested on the first Tuesday of each month at 10:00 a.m. for a oneminute duration. The sirens produce a loud steady tone during the monthly test as well as during an actual tornado warning.

RESIDENT RECOGNIZED FOR FAST ACTIONS

Lifelong Hodgkins resident Robert Buralli was recognized by the Village of Hodgkins for his actions during a fire at the Casciani's Restaurant located at Joliet Road and East Avenue.

On September 17th, 2008 Robert was going through the drivethrough window and waiting for an order to take home.

The owner of the restaurant was in the process of making some

repairs and cleaning the kitchen area. As the workers were removing some appliances, the gas line became disconnected and ignited a large gas fire.

Fortunately, for Casciani's, Robert works in the heating and air conditioning trade. He recognized the immediate danger of the disrupted gas line.

The immediate response a n d by intervention Mr. Robert Buralli resulted in being fire t h e extinguished with no serious damage to the restaurant and even more importantly, n o employees or patrons injured.

On behalf of the Village of Hodgkins, we would like to recognize and thank Robert Buralli for his actions in extinguishing this fire. His actions exemplify the caring and compassion of helping our neighbors and fellow man, which makes this Village such a great place to live.

PUBLIC WORKS EMPLOYEES RECEIVE AWARD

Department of Public Works Foreman Dennis Folkerts, Jody Kovel and Matt Struve were recognized for their involvement in stopping a residential burglary.

On October 14, 2008 the three employees were working and noticed some suspicious subjects walking around a house. The DPW crew noticed

the subjects check out the front door and then walk into the rear yard of the house. They knew the subjects did not belong at that residence and began shouting and ran toward the backyard at the



offenders. Before the crew had a chance to call the police, Officer Mike Pawlowski noticed the activity. The incident resulted in two offenders being arrested and charged with Residential Burglary.

These three employees demonstrated their dedication by paying attention to what might be unnoticeable to some.

They knew the area and knew that the actions of these offenders were suspicious. The Village awarded these employees with commendations for their actions.

IN MEMORIAM: SHIRLEY DRENNING

In 2008, the Village of Hodgkins lost a dear friend and dedicated public servant. Shirley Drenning served the Village as Treasurer, Comptroller, Civil Service Commissioner and as Trustee with the Township of Lyons. For over 20 years Shirley served our Village with a sense of dedication and compassion.

In 1999, Shirley retired from full time work as the Village Comptroller. During a luncheon in her honor celebrating her retirement, she informed the Hodgkins Police Department that she wanted to

donate \$3,500.00 to fund a scholarship in the name of the Hodgkins Police *DARE* Program. The Hodgkins Fraternal Order of Police Lodge #151 agreed to manage the fund along with the existing

Hodgkins FOP Scholarships. The Fund has issued a \$500.00 College Scholarship to a graduate of the Hodgkins Elementary School *DARE* Program ever since. She did not want her involvement publicized or any recognition for her donation.

Following Shirley's passing last year, the Hodgkins FOP met and unanimously agreed

to continue this scholarship and to officially name it the *"Shirley Drenning Memorial DARE* Scholarship".

After retiring from full-time service, Shirley was elected to the Township of Lyons Board of Trustees. She also was appointed to serve as a Civil Service Commissioner for the Village of Hodgkins. Even though her full time commitment was over, she maintained a serious dedication to serving our community

and represented the Village professionally and honorably.

At the 2008 Village Christmas Dinner, Gene Drenning, Shirley's husband was given a plaque



honoring Shirley for her service to our Village and Community. A duplicate plaque will be on permanent display inside the new Noel B. Cummings Administration Center.

Shirley is survived by her husband Gene and daughter Priscilla and Grand-daughter Cheyenne. She is loved and missed by all of us.

For the past several years I have been saving aluminum pop can tabs and taking them to the Ronald McDonald House located by Loyola Hospital. The Ronald McDonald House is a "Home-Away-From-Home" temporary lodging facility for the

families of seriously ill children being treated at

nearby hospitals. There are 270 Ronald McDonald Houses in 30 different countries. In total, more than 6,000 bedrooms are available for families every night.

Ronald McDonald Houses collect pop tabs instead of entire aluminum cans because the tabs are pure high-



quality aluminum, unlike cans, which consist of aluminum and other alloys. Tabs are also easier to store than whole cans.

With the help of several business's and families who collected tabs, we were able to drop off 45



Pounds of aluminum tabs last September. There are too many companies and individuals to list, but you know who you are and why you help.

So the next time you pop open an aluminum

can, pull the tab off and save them. You can drop them off at the Hodgkins Police Department or if you need, just call, and the Chief will make sure they get picked up.

Thanks for your help and we will keep you posted on how many tabs we turn in this year.

COMMEMORATIVE STAMP TO HONOR BOB HOPE

On May 29 the Postal Service will host a ceremony on the deck of the USS Midway in San Diego in recognition of Bob Hope (1903-2003). The stamp in his likeness on what would have been his 106th birthday is based on a photograph of Hope.

Hope devoted his life to making people laugh. He is most known for his unwavering commitment – from World War II through Operation Desert Storm – to supporting morale by entertaining military personnel serving overseas.


Bob Hope became one of the most honored and beloved performers of the 20th century. Although Hope never officially served in the U.S. Armed Forces, he dedicated a significant part of his life to entertaining America's men and women in uniform, starting in 1941 and continuing through the Persian Gulf War five decades later. After giving hundreds of performances overseas, he earned the nickname "G.I. Bob" and in 1997 became the first person

> recognized by the U.S. Congress as an "honorary veteran of the United States Armed Forces."

> Hope's thousands of honors also included the Congressional Gold Medal and the Presidential Medal of Freedom. Among his many friends were several U.S. presidents, with whom he often played golf for charity. Bob Hope died at his home in Toluca Lake, CA, on July 27, 2003, two months after his 100th birthday.
