

I want to first wish you all a very Happy New Year! I hope that all of our residents are doing well and enjoying this fairly mild winter that we are experiencing, so far.

Our community is looking forward to some great improvements this year and at the same time, completing some projects that we have been working on for some time. This spring should start the construction for the Runnion Crane Sales and Service and the Chevrolet Auto and Mid Size Truck Dealership to the vacant property on East Avenue. The Village has been working on this development for a couple of years and we are very excited to see the project begin.

One of the largest property development plans that we have taken on in many years, is the Lenzi Avenue Apartment Building purchase and demolition. This project began with the village addressing the building code violations and attempting to get the building owners to correct these issues to improve the living conditions for those residents. We began this project with the sole intention of requiring the building owners to

upgrade these buildings. It became apparent that the owners were not going to invest any money into these buildings, presumably due their deteriorating conditions. We were presented with the opportunity to start buying the buildings, and we did.

By September 2016, the Village took ownership of all ten buildings. These buildings were in such deteriorating condition, it was not feasible to do any renovations. We implemented a re-location plan for those residents. Basically the buildings were not safe and we were concerned for the welfare of those residents. This was not an easy task and is certainly an emotional undertaking for many families, some of whom have lived in the apartment complex for decades. We have had tremendous success in helping to place these residents with the help of a few local agencies, including the BEDS Program. Without a doubt, Mrs. Marci Ortiz, of School District 105 has been a great asset for our village and those residents over the last year. She has assisted with the re-location of over 138 families since we began. Four buildings have already been demolished and the remaining six buildings are scheduled to be torn down by this summer.

## New Laws For Illinois In 2017



Each year the State Legislature adopts more laws. In an effort to keep you up to date, here are a few of the new laws.

### PUBLIC SAFETY:

**<u>RAILROAD CROSSINGS</u>**: Drivers who drive around lowered gates at grade crossings will face stiffer fines for violating railroad crossing laws. Fines will increase to \$500 for the first offense and \$1,000 for each subsequent violation.

TRUSTEE PHIL KRINGLIE CHIEF OF POLICE (RET) **BLUE LIGHT ON MOTORCYCLES (HB 4105/PA 99-0598):** Allows motorcycles to be equipped with a blue light or lights located on the rear of the motorcycle as a part of the motorcycle's rear stop lamp or lamps.

**DOMESTIC VIOLENCE AWARENESS:** Hairdressers, nail technicians, braiders, cosmetologists and estheticians applying for or renewing their state licenses are now required to take one hour of continuing education to spot signs of domestic violence or sexual assault and provide clients with resources to get the help they need.

**<u>ROUTE 66 MOTORCYCLE PLATES (HB 4315/PA 99-0865)</u>:** Allows the Secretary of State to issue Illinois Route 66 license plates to motorcycles having an engine over 150cc.

**<u>FIREFIGHTER MOTORCYCLE PLATES (HB 5649/PA 99-0812)</u>:</u> Allows the Secretary of State to issue Illinois Fire Fighter's Memorial license plates to motorcycles having an engine over 150cc.** 

**VEHICLE REGISTRATION EXPIRATION (HB 5651/PA 99-0644):** Allows the Secretary of State to require an owner of a car or light truck to select his or her birthday as the motor vehicle's registration expiration date. If the motor vehicle has more than one registered owner, the owners may select one registered owner's birthday as the date of expiration.

### **OFFICIAL STATE ARTIFACT**

Designates the pirogue, a long narrow canoe made from a single tree trunk, as the official state artifact. The idea came from an eighth-grader at St. Joseph School in Wilmette, whose research uncovered the fact that, unlike some other states, Illinois did not have an official artifact.

The students suggested the pirogue, which members of the Illini tribe historically used to navigate the region's rivers and lakes.

### POLICE DEPARTMENT AWARDS CERTIFICATE OF COMMENDATION

Presenting The Certificate of Commendation Mayor Noel Cummings - Ofc. Frank Beran - Chief Ernest Millsap Do you know who you'd go to with a self-defense tactics question, or for a good take on the MMA professional sport fighting world? Do you have a professional personal defense and protection go-to person? I do. Without hesitation, I can say I'd talk to Officer Frank Beran of the Hodgkins Police Department. On Monday, January 9th, he and Officer Kelly Beyer were publicly recognized by Chief Millsap, Mayor Cummings, and the Village Board with commendations for exemplary services rendered in the performance of their duties.

Officer Beran's commendation recognized his exemplary actions in response to a call for assistance from the Willow Springs Police Department in September. Responding to a call about an armed

robbery at the 7-Eleven on Archer Avenue in Willow Springs, Officer Beran located the subject in a nearby bar. Taking control of the situation, Officer Beran used his vast experience in defensive tactics to subdue and disarm the subject, securing the scene and taking the subject into custody without injury to himself, the subject, or any of the other officers or patrons on scene. Ofc. Beran diffused and took control of a situation that could potentially have been deadly with his expertise and cool professionalism.

Starting at the Hodgkins Police Department in October of 1991, Ofc. Beran was a philosophical fit from the start.

"I was interested in law enforcement because I believe in the rule of law, and I wanted to be involved in helping to promote a lawful and orderly society," he said when asked about it.

Assigned to investigations shortly after starting at HPD, Ofc. Beran acted for a period of time as a liaison between the department on the one hand, and drug informants and purchasers on the other. Additionally, he has participated in an ongoing operation to obtain information on gang activities, and in gang mitigation, for a number of years.

Best known for his defensive tactics expertise, Ofc. Beran has benefited from a lifelong pursuit of martial arts skills, beginning with Judo, then moving into Karate, boxing, Muay Thai, and Brazilian Jiu-jitsu. In addition, he's been seasoned with many years of competition within these disciplines. He brings all of these skills into his career as a police officer. Over the years, Ofc. Beran has been involved in both a consultation and in a direct, hands-on capacity in training officers in the application of empty-hand force techniques. He has also given speeches and training seminars, both here and for other law enforcement organizations. Most

recently, he has helped lead an ongoing, active training regimen at HPD with the implementation of his personally-designed Empty-Hand Force program, an amalgam of various techniques and training philosophies he's learned over the years and has now incorporated into a formal discipline for the department. All of the Hodgkins police officers have benefited from this training, as it helps equip them to better protect and serve our community.

Let's all greet Ofc. Beran and thank him for his service when we see him around town!

The Village also hosts a food pantry with the Chicago Food Depository. This year we hosted two days. See dates below.



### POLICE DEPARTMENT AWARDS CERTIFICATE OF COMMENDATION

If you've lived in Hodgkins for any time at all, there's no doubt you've seen Officer Kelly Beyer around town. A longstanding fixture of our community, she is especially well known for her involvement with Hodgkins youth and their families in her capacity as a Juvenile Officer. On Monday, January 9th, she and Officer Frank Beran were publicly recognized by Chief Millsap, Mayor Cummings, and the Village Board with commendations for exemplary services rendered in the performance of their duties.

Officer Beyer's commendation recognized her life-saving intervention in an incident back in July, when a young patron at Applebee's restaurant was choking on a piece of chicken. Ofc. Beyer arrived on scene to discover that an employee had

brought the 11-year-old patron outside, where he and his parents awaited the arrival of the ambulance. The employee had already started to administer the Heimlich Maneuver, and had managed to get a partial dislodge of the obstruction. Ofc. Beyer quickly administered the Heimlich and succeeded in getting the food fully dislodged, thus clearing the child's airway and allowing him to breath.

Officer Beyer first came to work at Hodgkins Police Department in July of 2005, after serving in the United States Marine Corp. Because she had witnessed some of the devastation and tragedy in young people's lives stemming from the harmful effects of drugs in society, she developed a passion for the hope presented by law enforcement.

"I wanted to intervene in the lives of youth, at a time in their lives when so much of their life should be ahead of them. I wanted to make a difference, especially through community policing," Beyer said when asked about it.

Ofc. Beyer has served in a number of capacities at HPD. She is a state-certified Juvenile Officer, a state-certified Evidence Technician, a certified Bicycle Officer, and she works part-time with the Investigations Division as a TAC Officer.

### HAVE YOU HAD A RECENT FALL?

Falling Can Be Serious. In older people, one out of five falls cause a serious injury such as a broken bone or a head injury. Each year, 2.8 million older people go to the Emergency Room because of a fall. Over 800,000 people are hospitalized each year because of serious head injury or hip fracture.

Falls which cause head injuries can be serious, especially if the person is taking certain medicines like blood thinners. An older person who falls and hits their head should see the

doctor right away to make sure there's no brain injury.

Injuries due to falling can make it hard to get around and manage everyday activities. People who fall, even if there is no injury, become afraid of falling again. This fear may cause people to cut down on everyday activities, becoming weaker and increasing the chances of falling again.

#### TAKE A SAFETY ASSESSMENT OF YOUR HOME

There are many simple and inexpensive ways to make a home safer and prevent falls. For professional assistance, consult an Occupational Therapist.

• Lighting: Increase lighting throughout the house, especially at the top and bottom of stairs. Make sure lighting is easily available if you get up at night.

• Stairs: Make sure there are two secure rails on all stairs.

Bathrooms: Install grab-bars in the tub/shower and near the toilet. Consider using a shower chair and hand-held shower.

### STAY STRONG...AVOID FALLS

Are you holding onto walls, furniture, or someone else when walking? Do you have difficulty arising from a chair? These are signs that it might be time to see a physical therapist. A trained physical therapist can help you improve balance, strength, and gait through exercise. A therapist may suggest a cane or walker—and provide guidance on how to use these aids. Follow their advice. Poorly-fit aids actually increase the risk of falling.

### DEPARTMENT OF PUBLIC WORKS UPDATE

The Public Works crew has been keeping busy over the winter months, even with the mild winter that we have experienced. We have a large reserve of road salt due to the mild winter.

Last year we approved the construction of a new Salt Dome storage building. This was something that we had talked about for several years and was prompted by the unsafe conditions of the old salt storage facility that was constructed over ten years ago behind the Public Works building on 67th street.

The previous facility was a make shift storage bin that was made of large concrete construction blocks and had a metal framed canvas roof. The safety concern came from the metal frame roof structure being located directly under the power lines. When the frame was being assembled,

workers were getting electric shocks and we had to have the frame grounded. This raises a big concern for employee safety.

The new facility will store more salt and is located in the rear of the old firehouse on Santa Fe Drive. By placing the dome at this location, our residents will not be exposed to the view or more importantly the noise from loading salt trucks in the middle of the night. The life span of these salt domes run about 30 years and this will serve our needs for a long time to come.

We have replaced the LED fixtures on Kimball and Kane Avenues. These were the first generation of fixtures that were used and they were purchased with the help a a Cook County Community Block Grant a few years ago.

We will be looking at fixing more concrete parkways and curbs this year. We were able to get a few done last year and hope to complete the rest this year. If you have a question or concern about your parkway apron and/or curb, please contact the Village Hall so we can get any repairs scheduled.

I am happy to announce that for the last three years, we have been able to keep our residential water rates stable. Our commercial water rates have only increased mainly by the rates that the City of Chicago pass on to its customers. For 2017, we are once again keeping the residential water rates the same. No increase in water rates is another benefit to our residents.

We have also upgraded the computer system and software to help monitor water usage. A few of our residents have benefited from this already. When our system alerts us on a continual water usage event at a residence we are able to make contact and advise the home owner of a potential problem. Often times, it is just a running toilet or faucet. A running toilet can substantially increased your water bill, so be alert and check your bathrooms.

# Skunk Season (s Gere!



We had several calls about skunks last year. They are extremely hard to trap and for obvious reasons, difficult to handle. Striped skunks are common and found throughout Illinois. Rural areas with rolling hills or bluffs and a mixture of farmland, timber and pastureland tend to support the highest numbers. Striped skunks are abundant in some urban areas, especially those located along railroads or high-tension power lines because these features provide travel ways and denning

#### sites.

Breeding begins in February and lasts through March. The pregnancy period ranges from 62 to 72 days. A single litter of four to 10 young is born from early May to early June. Newborns don't have much hair, but still show faint black and white color markings. Litter mates can have different patterns, ranging from broad white stripes to nearly no stripes at all. Young skunks begin to leave the den and take short trips with their mother by late June or early July. They grow rapidly, nearing adult size in about a year. **Stay Alert!**

Our police department will now be carrying EVZIO. EVZIO is an opioid antagonist indicated for the emergency treatment of known

or suspected opioid overdose, as manifested by respiratory and or central nervous system depression in adults and pediatric patients. **EVZIO** is intended for immediate administration as emergency therapy in settings where opioids may be present. It instantly reverses opioid overdoses by blocking the drug from Interacting with the brain's receptors. This medication is used for the emergency treatment of known or suspected opioid (narcotic) overdose. Serious



overdose symptoms may include unusual sleepiness, unusual difficulty waking up, or breathing problems (ranging from slow shallow

> breathing to no breathing). Other symptoms of overdose may include very small "pinpoint" pupils, slow heartbeat, or low blood pressure. If someone you know is experiencing any of these symptoms please call 911 or the Hodgkins Police Department 24 hour dispatch 708-352-4476.


