## ORDINANCE 19-02

### AN ORDINANCE APPROVING OF PLAT OF ALLEY VACATION TO D & S TRUCK CENTER

**WHEREAS**, the D & S Truck Center (“D & S”) has recently completed construction of a new office and truck repair building adjacent to where their original building exists; and

**WHEREAS**, the expanse of the original and the new building traverses an alleyway owned by the Village of Hodgkins (“Village”); and

**WHEREAS**, the alleyway is above Village utilities, the alleyway itself is no longer to be utilized as a thoroughfare; and

**WHEREAS**, D & S is desirous of using the surface of the Village alleyway for parking and movement from the original building to the new building;

**NOW THEREFORE BE IT ORDAINED** that the President and the Board of Trustees for the Village of Hodgkins do the following:

#### Section 1

That a Plat of Vacation be prepared that accurately reflects the alleyway in relation to the boundaries of the D & S property.

#### Section 2

That the Plat of Vacation grant the right of surface use of the alleyway for parking and traversing over.

#### Section 3

That the Village retains the right to perform necessary maintenance and repairs on the utilities within the alley way.

#### Section 4

That the President and Village Clerk are hereby authorized to sign the Plat of Vacation described herein.

#### Section 5

If any action, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity shall not affect any of the other provisions of this Ordinance.

Section 6

All ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed insofar as the conflict herewith.

Section 7

This Ordinance shall be in full force and effect from and after its adoption and approval. The Village Clerk is directed to publish this Ordinance in pamphlet form after its adoption,
