

## **ORDINANCE NO. 19-08**

### ***AN ORDINANCE AMENDING TITLE 4, CHAPTER 2, SECTION 8D OF THE VILLAGE CODE OF HODGKINS "GAMBLING"***

***BE IT ORDAINED*** by the President and the Board of Trustees of the Village of Hodgkins, Cook County, Illinois, as follows:

#### **Section 1**

That Title 4, Chapter 2, Section 8D of the Village Code of Hodgkins entitled "Gambling" be and it hereby is amended and adopted to read as follows:

#### **Section 4-2-8D:**

"D. Gambling: It shall be unlawful for any licensee to suffer or permit any species of gambling in his premises or any part thereof or any place adjacent thereto under his control; provided however, that any licensee that has been approved by the Illinois Racing Board to conduct intertrack wagering and by the Illinois Gaming Board to conduct sports betting at its premises shall be exempt for this subsection. Nothing in this subsection shall prohibit the operation of video gaming devises in liquor dispensing establishments as authorized by the Illinois Gaming Board under 230 ILCS 40/1 et. seq.

#### **Section 2**

If any action, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity shall not affect any of the other provisions of this Ordinance.

#### **Section 3**

All ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed insofar as the conflict herewith.

#### **Section 4**

This Ordinance shall be in full force and effect from and after its adoption and approval. The Village Clerk is directed to publish this Ordinance in pamphlet form after its adoption


