There will be revisions made to TIF 3 (East Avenue TIF) in the next couple of months. We will be able to repeal that TIF and establish a new TIF which will reflect a much lower Equalized Assessed Evaluation (EAV) which will help in our increment for that East Avenue development. Also, Wednesday a number of citations from Code Enforcement and Building Inspector through the Police Department, certain buildings on Lenzi Avenue have been ticketed.
