

## Village of Hodgkins Communicator

#### A Message from Mayor Noel B. Cummings . . .

1980 was a big year for John O'Connell. It was also a big year for the Village of Hodgkins. In August of that year John was in the midst of his campaign for Illinois State Representative. It was also the month I hired John as our Village Attorney. He did get elected in November and went on to serve 8 years. During his four terms he distinguished himself as a dependable and energetic State Rep. He served as Chairman of



both the House Judiciary Committee and a very important Committee on Debt Financing. He developed and passed into law significant changes in the way government and private business could work together for the benefit of the people they each served. It was no coincidence that in just a few years after he was hired, the Village of Hodgkins began construction of the Quarry Shopping Center. That was followed by Target, Menards and Toyota. These successful projects were a result of utilizing Tax Increment Financing with a streamlined bond issuance system passed by John O'Connell while in the House of Representatives. The legislative programs passed by John and his colleagues worked. In 1980 the Village had only \$30,000 in sales taxes annually. Now we receive \$5,000,000 each year.

One other development tool John brought back from Springfield: the Enterprise Zone. In 1985 the Villages of Hodgkins and McCook created an Enterprise Zone that still exists. In 1990 we had only one business on River Road, Silbrico. Now we only have about 3 acres that remain vacant. In 1990 we annexed about 60 acres of land along Santa Fe Drive and south of LaGrange Rd. That annexation put us adjacent to the old Fisher Body plant that had just announced its closure. As everyone knows, that is now the UPS CACHE facility. The largest in the world. It was the Enterprise Zone that did it. We are proud of the thriving industrial community we have along River Road and Santa Fe Drive.

Unlike many other communities, we do not have a formal Village Administrator. We do have John O'Connell, who functions as our Village Administrator. Along with Melody Salerno, they run the day to day

operations of the Village. We depend on the wealth of experience John has brought from his days as a legislator but also the 30 years he has represented many fortune 500 companies as a lobbyist in Springfield. He includes Microsoft, Fed Ex, Reynolds and Rivers Casino as some of his clients. His office, however, is at 8990 Lyons Street, Hodgkins. Back in 1980, when I asked him to be our Village Attorney, he stated that he had never worked as a municipal lawyer. I told him that I had never been a Mayor. I said: "We will learn together". After 40 years together I think we did a pretty good job.



#### **Water Rate Increase**

Starting March 1st 2020, but not reflected until the following billing cycle all water rates will increase by 15%.

- △ Senior Rates are going from \$4.42 per 1000 gals to \$5.08 per 1000 gals (Min charge 7000 gals)
- A Residential Rates are going from \$6.31 per 1000 gals to \$7.26 per 1000 gals (Min charge 7000 gals)

# POLICE LIEUTENANT CHRIS MILOJEVICH **BEGINS WELL DESERVED RETIREMENT**

On January 3rd, 1991 Chris Milojevich began his career with the Hodgkins Police Department.

His interest in Law Enforcement came early, he had two uncles who were Chicago Police Officers. While he was in High School. His older brother, Kirk, was killed by a drunk driver while serving in the Air Force.

After from Lyons Township High School, he

attended Western Illinois University and studied Criminal Justice. He received his Bachelor Degree from Western Illinois University and started searching for police jobs. While testing for police departments, he was able to get a police dispatcher job with the and Indian Head Park Police Countryside Departments.

Once hired by the Hodgkins Police Department, he attended the Cook County Sheriff's Police Academy. Soon after graduation, Officer Milojevich was made a Juvenile Officer. A new program had started in Illinois, based after a Drug Program started in Los Angeles California. The program was looking for officers with 5 years of street experience to teach the curriculum that would help elementary school age

help our local students, of all grades. He started programs for the DARE Class that would not only teach them the hazards of drugs and alcohol but also teach them community involvement and mutual respect.

Ofc. Milojevich would teach DARE for the next 9 Years. His involvement with our local youth was truly amazing and sincere. He started and participated in Youth Sports Leagues, multiple fund raisers for the DARE program that included car washes to Police Basketball games. His goal was to show our kids that Police Officers were good and that they could always count on the police to help them. Officer Milojevich was a tremendous teacher and a great representative for the Hodgkins Police Department.

In 1993, the Youth Division put together an Annual Anti-Gang Day at the Hodgkins Elementary School. This event was welcomed by then Principal Paul Vorwick and would allow for our Police Officers to spend the day with the students and

agreed to sign the required waiver so Ofc. Milojevich would be accepted to the program. So in 1993, the Hodgkins Police Department started our DARE Program the Hodgkins with Elementary School. It would be focused on Sixth the Grade students. Officer Milojevich was our First DARE Officer.

During his time as DARE Officer, Milo would dedicate much of his personal time to



discuss street gang dangers and ways to stay away from gangs. This program was later combined with Annual Safety Day at the School.

Ofc. Milojevich and the Hodgkins Police Administration Assistant Elaine Thompson planned out the curriculum for

a day with the students that taught them all kinds of safety programs.

His involvement in the community did not end with the Youth Division. Milo was very active in the Hodgkins Fraternal Order of Police Lodge #151. During his time with the Department, he would serve as an Officer in the

Lodge on all levels. The Hodgkins FOP was also a big backer of the Police Youth Programs.

In 1998, Officer Milojevich started pushing the idea of the annual Golf Outing to help raise funds for the FOP. Officers Milojevich and Pawlowski put together an event that is still going on every year. The Hodgkins Golf Outing helps the FOP award College Scholarships for local youth and has, in fact awarded more than 75 scholarships over the years.

Programs that the Department and the FOP have

supported ranges from packing supplies for the troops, Candlelight Bowls, Christmas gifts for local families, College Scholarships, After School Tutoring and the Annual Bike-A-Thon for St. Judes Children's Hospital.

The Police Department started the Bike-A-Thon for St. Judes in 1990. Each year, the students from Hodgkins Elementary would participate in the event and would raise over \$102,000 from 1990-2016.

The success of our local FOP has been due to several members over the years, and Officer Milojevich has always been one of those involved. Officer Milojevich was Promoted to Sergeant in 2007 and was the Hodgkins Police Youth Division Supervisor, in addition to his shift supervisor duties. In 2015, Sgt.



Milojevich was Promoted to the Rank of Lieutenant. He was responsible for all training on the police department. He was also the Department Instructor for the A.L.I.C.E Active Shooter Preparedness



Program. The ALICE acronym stands for "Alert-Lockdown-Inform-Counter-Evacuate". This program is designed for training police and area organizations, schools, hospitals, businesses and government on what to do during certain emergency events such as an Active Shooter.

Lt. Milojevich married Joanne in 1988. They have three children, Kirk, Ryan and Jessica. The newest addition to the Milojevich family are two Grandchildren. The newly retired Lieutenant plans on staying busy in his retirement by babysitting those grandkids. LT. Milojevich begins his retirement on February 28th, 2020, what will he do?

He is an avid golfer and sports fan. He played Rugby in college and coaches rugby today. He also plans on staying involved with kids by Substitute

> Teaching a few days a months. LT. Milojevich reflected on his time on the Department,

> "I could not have found a better place to serve a community, but here in Hodgkins. My family and I are sincerely grateful to this Village".

Congratulations on your retirement LT. Milojevich! It is well earned and most of all, *Thank You* for your dedication and service to our community.

## **BIG PROMOTION NIGHT FOR HODGKINS POLICE**



For four members of the Hodgkins Police Department, the Monday night Village Board meeting of January 13<sup>th</sup>, 2020, was a very important and happy occasion. With friends, family, and community members gathered around, not to mention a sizeable contingent from the police department itself, the Village Board voted to approve three promotions, and to recognize a new officer joining the force.



Luis Calderon, who beat out a number of other police officer candidates in the Civil Service hiring process, was present with supportive family members and friends in attendance, as the board recognized and congratulated him as the newest member of the department. An officer with two years' experience working at the Clarendon Hills Police Department, Luis was officially sworn in on January 2<sup>nd</sup>, and has now completed a Field Training Program in order to acclimate to the policies and procedures of the Hodgkins Police Department.

Officer Frank Beran, whose career at the department has spanned 28 years, was promoted to the rank of Sergeant by a unanimous vote of the board. #### Cook County residents are now eligible to apply for Surviving Spouse Tax Abatement.

The Cook County Board of Commissioners and the Chicago City Council have passed ordinances to authorize a property tax abatement in their jurisdiction for the surviving spouses of Cook County's fallen heroes. The program serves surviving spouses of a fallen police officer, soldier or rescue worker. This program will recognize and honor the ongoing impact of this sacrifice of these families.

The program can abate up to 100% of a surviving spouse's Cook County and City of Chicago property tax liability. The Cook County Board of Review will administer the program, and surviving spouses apply for the abatement with us.

The Board of Review will consider applications and supporting evidence—hold a hearing if needed—and recommend gualifying applicants for final approval. If approved and admitted into the program, the surviving spouse may reaffirm the facts remain the same and continue in the program yearly.
