Mr. Struve asked for a motion to approve/deny 2012-2013 Renewal notice for MICA (insurance carrier) for \$138,770.00. Mr. Millsap asked Mrs. Salerno what was the premium for last year. Mr. Struve asked for a motion to approve/deny **Ordinance #12-3** Regarding Solicitation within the Village of Hodgkins. Mr. Callahan asks for the following changes on its face.

- Section 4-1 A-3 The section under permit required should have been stricken.
- Where it say a non-profit solicitor is not required to obtain a permit may also stricken.
- Section 4-1 A-9 under Limitations and Prohibitions. Under A, each solicitor shall wear at all times while engaged in solicitation in the Village a his/her solicitors safety vest issued by the Village and each solicitor shall present his/her permit upon request. Motion to approve with the changes by Mr. Millsap. Second by Mr. Rice. Voting Aye: Mr. Cuttill, Mrs. Moxley, Mr. Rice, Mr. Struve, Mr. Millsap and Mr. Christopher. Voting Nay: None.

Mrs. Moxley states that the purpose of this ordinance is so that the Village knows who is soliciting in the Village at any given time. This is a way we can monitor who these people are.

Mr. Struve asked for a motion to approve/deny Donations to the Hodgkins FOP Golf Outing. The fee for a round of golf for a foursome is \$400. Report from Village Attorney, John O'Connell

Mr. O'Connell reports on the status of the purchase of the property located at 6119, 6125 & 6129 East Avenue. Mr. O'Connell states that issue of Albie's Hilltop has been lingering for many years. We have approached the owners of the property in the past. There 21 heirs to the estate that owns that property. We have reached a place where there is an agreement of a sale price of \$400,000 for the property. A suggestion to the attorney for the owners was that we could file a complaint for condemnation, which he agreed was probably the best way to proceed because there was not a certainty that all 21 of the beneficiaries would agree. The complaint was filed because firstly the property is in a TIF and has been abandoned for six years. Thirdly, it is a property the Village needs for the development along East Avenue.

They have agreed to the amount of \$400,000 as just compensation. We have filed a motion for condemnation and a motion for an agreed judgment order in the amount of \$400,000. The motion is scheduled for hearing this coming Thursday, May 17, 2012, at which time we would submit our check in the amount of \$400,000, which would go to the Cook County Treasurer's office. From those proceeds, the outstanding taxes, which are significant, would be paid. The obligations of the owners of that property would be paid. We would then be in a position to get clear title to that property.

The ordinance before you is spelling out what has been described and gives Mr. O'Connell authorization to go to the judge on Thursday indicating that the President and Board of Trustees has agreed to judgment order, which would be entered on Thursday, May 17, 2012.

Mr. O'Connell states that an overwhelming majority of the beneficiaries want to do this. There are about \$91,000 in taxes to be paid. If they do not do this now they will lose the property on June 1st to a purchaser of the taxes.

Report from Chief of Police, Phillip Kringlie

- Chief Kringlie states that the Village Hall was used as the headquarters for the Bike-A-Thon. There were raffle prizes and lunch for the participants. \$4,200 was raised between the basketball game and the Bike-A-Thon plus cash donations.
