Report from Village Attorney John O'Connell:

Mr. O'Connell reported on the 75th St project. October 15, 2020 the Illinois Tollway Board meets to consider the sale of 31,000 square feet of land to the Village of Hodgkins. The developer will reimburse all costs for this. Closing is anticipated by November 1, 2020.

-Valley Oaks came back with an offer for the property swap. The cost will prohibit this swap from occurring. Trustees need to think about what they would like to do next.

Report from Village Attorney Pat Rogers:

Mr. Rogers reported the Old Fire Station needs an update to the computer system for the fuel billing system. The cost is approximately \$15,000, which will hopefully be split with Pleasantview Fire Department. This topic will be added to the next scheduled Building Committee Meeting

- -There was a meeting with the gentleman who was involved in an accident on 63rd St. which caused damage to the guard rail. The person's insurance should be reimbursing the Village for the cost of the guard rail repair within the next 30 days.
- -No information has been received from Novotny & Assoc. regarding a multi-use roadway/path that they would like to place on the North end of Joliet Road at the Quarry Mall. Mid-America will need to be contacted for comment once more information is received.
- -No further information has been received from the Justice of Willow Springs Water Commissioner regarding the Monopole they would like to add on the UPS property. Attorney Rodgers will work to make sure everything runs smoothly.
- -Early voting starts October 19, 2020. There are 34 Cook County Sheriff's Officers assigned to cover 40 Early Voting polling stations. This will add burden on to our Police Department.

Report from Building Inspector, Matt Struve:

Mr. Struve reported Waste Management has plans to enclose their property with a fence. They are awaiting a lease agreement from BNSF Railroad.
