# AN ORDINANCE AMENDING TITLE 10, CHAPTER 9: SPECIAL USE S ZONES

WHEREAS, a Special Use S Zone is the Chapter of the Hodgkins Zoning Code that provides for those uses that are either necessary of generally appropriate for the community but may require special regulation because of unique or unusual impacts associated with them; and

**WHEREAS,** A Special Use will be allowed only if it meets all standards and conditions imposed on it by Village ordinance;

**NOW, THEREFORE, BE IT ORDAINED** by the Village President and Board of Trustees the following:

#### Section 1.

Title 10, Chapter 9 SPECIAL USE S ZONE shall be amended by adding <u>Section 10-9-2-: Adult Use</u> Cannabis

All uses specified within Ordinance 21-06 shall only be performed within the Special Use area as approved by the Board of Trustees following a hearing before the Hodgkins Zoning Board of Appeals and legally described herein.
