An Ordinance Amending Chapter 4 of Title 4
“Business and License Regulations” of the Village of Hodgkins Code of the Village of Hodgkins,
Cook County, Illinois
“Business and License Regulations” (Amend 4-1A-1)

Type of Business

WHEREAS, the Village of Hodgkins, Cook County, Illinois (the “Village”) is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of The State of Illinois and as such may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the President and Board of Trustees of the Village of Hodgkins (the “Corporate Authorities”) may from time to time amend the text of the Village Code of Hodgkins when it is determined to be in the best interest of the residents of the Village; and

WHEREAS, the Corporate Authorities find it is in the best interest of the health, safety and welfare of the Village to amend the Business and License Regulations of the Village.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Hodgkins, Cook County, Illinois, by and through its home rule powers, as follows:

Section 1. Amend chapter 4-1(A) (1) schedule of fees of business and license regulations as follows:


