ORDINANCE 19-06

AN ORDINANCE ADOPTING TITLE 9, CHAPTER 7, SECTION 9, ENTITLED INSTALLATION OF AN AUTOMATIC FIRE SPRINKLER SYSTEM IN RESIDENTIAL DWELLINGS IN THE VILLAGE OF HODGKINS CODE

BE IT ORDAINED by the President and the Board of Trustees of the Village of Hodgkins the following:

Section 1

That there shall be added to Title 9 of the Hodgkins Village Code as follows:

Under 9-7-9: One and Two-family dwelling automatic fire sprinklers:

Add the following:

"A. The Village of Hodgkins will provide an incentive of 50% of the total cost for the installation of an approved NFPA 13D residential fire sprinkler system to any homeowner/contractor choosing to install this life safety system in their new or existing residential dwelling.

The following criteria will be used to calculate the total cost. The building contractor/home owner shall submit three bids. The average of all three bids will be used to determine the 50% incentive. The bids shall include:

- 1. Water main tap fee if required
- 2. Combined sprinkler and domestic water service
- 3. All piping and valves after the tee for the sprinklers
- 4. All installation and testing fees"

Section 2

If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity shall not affect any of the other provisions of this Ordinance.

Section 3

All parts thereof in conflict with the provision of this Ordinance are hereby repealed insofar as the conflict herewith.

Section 4

This Ordinance shall be in full force and effect from and after its adoption and approval. The Village Clerk is directed to publish this Ordinance in pamphlet form after its adoption and approval.
