Report from Village Attorney, John O'Connell

Mr. O'Connell gave an update on continuing condemnation matter. The Village acquired 8.2 acres of property that were obtained from the Dostal family in a quick take process. The title has been received, but the final sum of compensation was interim. We are now in court for the final confirmation. Another law firm has been brought in to help. The depositions of expert witness have been completed. This matter is hopefully going to be resolved by April.

Report from Chief of Police, Ernest Millsap

Chief Millsap reported that he and Trustee Rice have been working on enhancing safety of the Village of Hodgkins and the Mall area. The smart 911 system has been introduced. The system works with any phone, location of users using an I-phone or Android can be pinpointed almost exactly. People can sign up to receive emergency alert. There is still one more step in the process. Oak Lawn Central Dispatching is one of the first emergency response centers to offer smart 911 in the area. Residents will be notified via the next communicator on how to sign up for this free service. They are also in the process of updating all the 911 signs in the Village.
