Motion to approve/deny Ordinance #19-09 Amending the Municipal Code of the Village of Hodgkins by the deletion of Title 3, Chapter 3 Article F- Real Estate Transfer Tax and inserting in Lieu thereof Title 3, Chapter 3, Article F- Municipal Cannabis Retailers' Occupation Tax. Mr. O'Connell explained the Cannabis tax cannot exceed 3%. There will be a zoning hearing. 67% of the Hodgkins Residents voted to legalize cannabis. A Motion to approve Ordinance #19-09 was made by Mr. Rice. Second by Mrs. Mills. Voting Aye: Mr. Kovel, Mrs. Moxley, Mr. Rice, Mr. Struve, Mr. Misasi, and Mrs. Mills. Voting Nay: None

Motion to approve/deny a pour liquor license to BP Gas Station. Mr. O'Connell wants to verify that the Illinois Department of Liquor Licensing approves the pouring process. This license can be issued, but there may be changes in the future. Chief Millsap explained that a person in the Gaming Area cannot consume more than 3 drinks, and they have to stay in the gaming area.
