# A RESOLUTION AUTHORIZING THE RENEWAL OF CLASS 6b REAL ESTATE TAX INCENTIVE FOR PROPERTY LOCATED AT 6880 RIVER ROAD AND DESCRIBED BY THE PERMANENT INDEX NUMBERS AS PROVIDED HEREIN

**WHEREAS,** ORDINANCE NO. 07-12 authorized and approved for recommendation to Cook County the 6b real estate tax classification for the parcel owned by Hodgkins River Road Partners, LLC ("HRRP") with Permanent Index Numbers of 18-22-304-041 and 18-22-304-042; and

**WHEREAS,** since the date of the above Ordinance, HRRP developed the Industrial condominium building into 25 separate industrial condo units each of which has received 6b tax classification pursuant to Control # 62158 and are listed below:

All parts thereof in conflict with the provision of this Resolution are hereby repealed insofar as the conflict within.
