Motion to approve approve/deny acceptance bid of approximately 62,000 square feet of vacant property east of Lenzi Avenue. Mr. O'Connell explained this item was published in 3 separate publications of Des Plaines Valley News. The 30 day statutory period has come and gone. One bid was received. This property is also known by the common name of 6021, 6023, 6025, 6027, and 6029 Lenzi Avenue. The bid amount is \$558,504.00. A purchase and sale agreement is being worked on. This amount comes to \$9.00 per square foot. The bid comes from Carl M. Michaelsen III, manager of CMM III, LLC. Mr. Cummings is happy to have ODM as a new business in this town. Chapter 8 Mobile Homes and Mobile Home parks as follows: Inserting 10-8-9 the requirement for Mobile Homes and Mobile Home Parks. Section A: all mobile homes brought into the Village of Hodgkins following the effective date of this ordinance shall be new and adhere to these requirements. The word "used" has been removed and only new units will be allowed in the Village. Part 2 regarding foundations/slabs will be tabled and discussed at another Building Committee meeting. This portion will be put in Ordinance form. A motion to approve amendments to Title 10, Chapter 8 of the Mobile Homes and Mobile Home Parks was made by Mr. Struve. Second by Mr. Rice.
