

The Project consists of the Village acquiring distressed or foreclosed parcels, demolish the old building and sell the vacant parcel to a builder or future resident who agrees to construct a new residential building on the site. Prices



on the vacant parcels have recently been set at around \$60,000. We have purchased seven parcels in the past year. Two homes are completed and one is in progress of being built. Recent sales of newly constructed homes have been around \$400,000. I don't think it is too early to say the Project has been a success.

## MANDATORY HOME INSPECTIONS PRIOR TO RESALE

#### FOR ALL RESIDENTIAL BUILDINGS AND MOBILE HOME STRUCTURES

Inspections prior to resale shall only be required when selling a residential building or a mobile home with a structure 15 years or older at the time of sale.

This is a MANDATORY INSPECTION for all residential buildings or mobile home structures. It is the responsibility of the owner, (Seller) of the property to notify the Village of the impending sale. In the case of a mobile home the seller is required by our ordinance to make their park manager aware of the sale. The mobile home park manager is required to make the Village aware of the sale.

#### **ORDINANCE 18-11**

An ordinance inserting point of resale inspection requirements in Title 9, Chapter 14 in the Hodgkins Village Code.

As an Illinois Home Rule Municipality, the Village of Hodgkins ("Village") has a constitutional directive to protect and ensure public health, safety and welfare of its citizens insofar as they are affected by the continued occupancy and maintenance of residential structures and premises.

#### BUILDING PERMITS are required- 9-1B-2: 9

It is hereby declared unlawful for any person, firm, or corporation to commence or to perform or engage in any work in connection with the construction, erection, enlargement, remodeling, altering, repairing, raising, lowering, underpinning, change of use, moving or wrecking of any building, structure, or portion thereof without having first made application to and secured the necessary permit therefor. Any person, firm, or corporation so doing shall be subject to the general penalty for violation of this chapter. The building permit shall carry with it the right to install any crane, derrick, material elevator, heating or lighting apparatus inside the lot line which may be required for temporary use during the progress of the work.

#### Fair Housing Act

The Village of Hodgkins is committed to promoting Fair Housing efforts through fair and equal housing opportunities for our citizens. Fair Housing is the right for all people to have safe, decent housing and be able to get this housing without discrimination. Village, State,

and Federal Fair Housing laws require that all people have an equal opportunity to buy, rent, or live in housing. Title VIII of the Civil Rights Act of 1968 (Fair Housing Act), as amended, prohibits discrimination in the sale, rental, and financing of dwellings, and in other housing-related transactions.

#### FEDERAL FAIR HOUSING LAWS PROHIBIT DISCRIMINATION BASED ON:

RACE, COLOR, RELIGION, NATIONAL ORIGIN, SEX, FAMILY STATUS, DISABILITY Complaints of discrimination in housing can be filed with the Village of Hodgkins, the Illinois Department of Human Rights, or the U.S. Department of Housing and Urban Development.

### It's Tax Rebate Time Again

The Residential Tax Rebates are paid to those residents who receive property tax bills from Cook County. The Tax bill must have homeowners exemption. Proof of payment is required. This is obtained by a receipt from your bank or lender. The Village will reimburse you the Village of Hodgkins portion listed on your tax bill plus 10%. If you have not filed for your Property Tax Rebate yet, please contact the Village Hall for information.

Mobile Home residents and those residents that rent or lease an apartment are eligible for a garbage rebate as long as you have resided in Hodgkins as of January 1st, 2018 and still reside here. These rebates will be available starting November 14th, 2018 through December 14, 2018.



# SMOKE DETECTORS SAVE LIVES!

The Village offers FREE smoke detectors to Village residents. If you already have a detector it is recommended that you replace batteries in your smoke and carbon monoxide detectors every six months. An easy reminder is to use daylight savings time.

#### Fire Prevention and Safety Tips

More than half the reported home-cooking fire injuries happen when people try to fight the fire themselves. Before using a portable fire extinguisher, make sure you know how to use one. Also, it's crucial that you have an extinguisher that's the correct type for the fire you're fighting. Also, it's important that all people have left or are leaving the house, you have a clear escape route and the fire department has been called.

Be alert! If you're sleepy or have consumed alcohol, don't use the stove or stovetop. Remain in the kitchen while cooking food on the stovetop or in the broiler, and use a timer to remind you to check it regularly. Keep an eye on what you fry.

Annual inspections and tune ups to keep heating systems and furnaces in peak, safe and efficient operating condition. Keep the area around the furnace free from obstructions and flammable items. Change the furnace filter regularly for energy efficiency and to keep dust from being circulated through the house. Keep anything that can burn at least three feet away from heating equipment, like the furnace, fireplace, wood stove or portable space heater. Have a three-foot "kid-free zone" around open fires and space heaters.

Keep matches and lighters up high, out of children's sight and reach.

Never smoke in bedrooms. Never smoke in a home where oxygen is being used.

#### Have an Evacuation Plan:

Draw an evacuation map so that it's easy for your little ones to understand what their route will be to get outside. Keep it on the fridge year-round so it's always top of mind.

Establish a family meeting spot outside the home – and remind everyone where it is.

Identify two ways out of each room in your home and make sure the exits are always free of furniture or clutter.

Assign one person (an adult or parent) to keep track of the cat or dog, so that everyone isn't looking for a beloved pet during an emergency.

Practice escaping from your home.

Make sure everyone knows how to call 9-1-1.

Teach household members to STOP, DROP, and ROLL if their clothes catch fire.
